3307/2003 REPORTS OF THE COUNTY COUNCILLOR AND CITY COUNCILLORS.

Budget not too horrendous this year, some savings needed but in the years ahead it could be very challenging.

There is a Consultation open at the moment on the County Council website regarding a proposed Combined County Authority.

'In November 2023, the Government announced it would be willing to enter into a devolution deal with Lancashire County Council, Blackburn with Darwen Council and Blackpool Council.

The deal, if given final approval, will transfer new money and powers from central Government to a newly created Combined County Authority, allowing it to tackle key local priorities.

The deal would not require a change to the established democratic structures across the county or the need for an elected mayor. It will not require an extra charge on council tax.' Lancaster City Council have not been included in these talks. Funding may be taken away from local level and the districts may have less influence. <u>Consultation - Lancashire Devolution</u> Cllr Greenwell

1) Digital Divide (see document)

I keep coming across examples of people on the wrong side of the digital divide -- i.e. they cannot handle the online world and are cut off from resources, such as booking online medical resources or online banking.

EG1:- At Furness line meeting, there was indignation about Carnforth station parking, where you need a smart phone & the Ringo app. Cash or cards are of no use. The consequence is travellers park away from the station.

EG2:- A Council Housing newsletter was sent out digitally. Tenants need to know about a hard copy option.

EG3:- A gentleman with a Telecare bill and no laptop or smartphone needed my help.

Approximately 8% of households don't do digital so are, given the trends, increasingly deprived. What can be done about it? Is there/ought there to be a village initiative to help people get online?

What can we do locally? There is plenty of need, Carnforth Station has been an issue for locals. Could we offer training? Or link into colleges? Is there a place for simple advice, such as at coffee stop, where people could come for individual advice. We would need a techy person to volunteer to help. Issues around safeguarding and confidentiality, it would need a protocol drawing up.

Action Clerk to ask Cllr Greenwell to elaborate on this. Also raise it with VH committee and CS volunteers.
