## **Cllr Greenwell**

A new District Local Plan is being developed. This is a massive piece of work covering many elements including infrastructure, industry, employment, housing, climate change.

This will incorporate the Local Area Energy Plan (LAEP) due out this Summer. A probable new housing target of 400+ homes per year is anticipated.

The most important element of the Plan affecting us is the Arnside & Silverdale National Landscapes Development Plan of 2019; I am told that this will not change.

Submission of the Plan to Government inspectors will be in around 15 months (Summer 2025). There is a 'Local Plan Hub' on the Lancaster Council web site. Local Plan Review (arcgis.com)

Garden Village plan has been dropped by the County Council due to escalating cost. So a new plan is needed to meet the Governments target on new housing, so instead of the Garden village these will be spread over the whole district. Each parish to put forward their suggestions for housing development and to complete questionaires on what local services are available.

Biodiversity Plan net gain of 10% on any development, but this does not need to be within the area. More expensive to offset biodiversity loss on a national scheme but this may not. Good idea to put forward local ideas for where financial support for biodiversity gain might be beneficial. Representatives are available to come and speak to us if we need. Small developments may be allowed in the National Landscape area.

Cllr Tyldesley (also involved in the DLP)

Budget for the district council is a balanced budget, largely thanks to the levy on Heysham power station. Green bins have gone up but mainly by inflation. Carparking is also up. The big issue is homelessness and housing people in BandB's but this is a national issue. Trying to get some new council housing going, borrowing money for this is complex.

Bus meeting, Silverdale have a bid in for funding, eventually the aspiration is for an electric bus. We have sent out some questions on FB to get some feedback on what is wanted from the bus service in Yealand.
