Clir Williamson – All is well, busy as usual, good finances, but the cost of meeting the rise in employer's contributions to National Insurance will be £16 million, this will be funded through increased efficiency including the use of Al. Creation of the Combined County Authority - The statutory documents will be published shortly and the new authority will be in place before the end of March (maybe sooner). The Combined Authority will draw down an extra £20 million from central government, and there will be no increased cost to residents. The CA has no tax raising powers in itself, so no precept. The recent Govt budget spoke of a possible local government reorganization. The history of Lancashire with its unique geography will make agreement on further changes, difficult to achieve. District councils to remain the same. The district leaders have agreed who will sit on the Combined Authority.

#### Report by Cllr. Alan Greenwell to Yealands Parish Council 12/11/24

#### 1) The Budget & Council Funding

- a) According to the Budget Red Book, the government's impending devolution white paper will include working with councils to simplify their structures. The District Councils' Network has warned that this reorganisation poses a threat to district councils, as they could eventually be swallowed up into larger unitary councils. We watch this space.
- b) The Budget offers 3.2% real-terms increase for the whole sector in 2025-26 much of which will be directed to social care. This does not offer substantial relief but does draw back those councils near the cliff edge of bankruptcy.

### 2) Lancaster District Council Leadership Change

As you know, the Council is run by a coalition of Labour, Greens and LibDems. After the recent by-election, the Greens now have the largest number of councillors. Caroline Jackson is the leader of the Greens. Because the current Council Leader (Philip Black) is ill, Caroline, as Deputy, has been filling his role but is now likely to become Leader of the Council in her own right.

# 3) Lancaster Area Energy Plan (LAEP)

This has been published and approved by the Cabinet.

Lancaster Council plans to be net zero by 2030 for its own resources (such as Salt Ayre). The Laep plan outlines scenarios for the whole

district for net zero by 2050 (the current Govt aim), by 2040 & by 2035.

The funding for these plans will be some balance between individual

investment and central grants, yet to be revealed.

a lot more -- heat pumps need to be considered at some stage. Various

event, with a lot of interesting projects being reported on. Including their

Farming in Protected Landscapes (FIPL) funding – Coppice Co-op have been involved in bringing women from Accrington out for free on the train to do wood crafts.

They are about to write the Management Plan and some consultation has been going on. It would seem that the Government is strengthening protection of NL.

Arnside has a scheme to build 100% affordable housing, interesting project. Arnside PC bought the land.

Silverdale had a meeting Lune Valley Trust Passive housing (Halton) scheme. Unfortunately, no one was available from PC to attend. With this model, land is usually gifted to the Trust, so requires a generous benefactor.

Cllr Tyldesley has had an Air source heat pump fitted, only £4000 with the grant. Needed new pipes and radiators. Not been tested in the cold weather as yet.

Cllr Hancock is going to meet up with the MP Lizzie Collinge at Leighton Hall and will take local issues.
