The move to include Morecambe Bay area in a wider authority with South Cumbria, has now been dropped. Parish Councils in the south of the area were opposed to being merged with Cumbria.

Big changes afoot - New deal for Greater Lancashire with the intention to form a partnership of district and county council. To include more powers for finance and

decision making. This is to be decided within L.City.C in the next month. Not a merger but a way of finding more efficiency, as there is a lot of waste in systems and departments on logistics. Too many links in the chain.

Amalgamation gives us more efficiency and better purchasing power, reduce waste

We already outsource to Preston a number of services such as auditing there could be a saving on this as it would become an internal process. Parish Councils do not have a very loud voice especially in areas such as planning.

Councillors have power over policy but not over implementation. Council officers have more technical skill and action decisions.

Silverdale brought in the Director of Environmental services to talk to the Councillors and this was a very useful exercise.

Playpark – report Cllr De La Mare has asked for a cost analysis on complete repair (based on the report that was released this week) or dismantle and renew. Hold off on mending it or get approval on any running repairs. Cllr Harbison had also sent through details on this. A possible source of funding for repairs might be BARN they have funds for community projects.
